September 17, 2018: HSM engineering discovers there may be an issue with the NextGen 45" 3PT seat while testing for a modification of the current product. At this time it was not known if this was due to the modification or affected the current production seat. October 22, 2018: HSM engineering determines that the NextGen 45" 3PT seat was in non-compliance. The NextGen 45" 3PT seat is not a high volume product since it is only purchased historically by school districts in New Jersey - New Jersey requires 45"-30" seating and is the only state that does so. The last manufacturing date of this product was 9/25/2018. And there were future orders for mid to late October. October 23, 2018: HSM engineering conducts testing to verify a remedy. October

24, 2018: HSM engineering contacts Blue Bird informing them of our intention to recall the NextGen 45" 3PT seat. This seating product is sold exclusively to Blue Bird.
