On Monday November 19th a review of the yard identified several units missing the reflector either on the DS, PS or both on about 25% of what was in the yard produced by plant 7B and was put on a shipping hold. on November 20th the yard was reviewed and any missing reflectors were corrected, due to company closure for holiday the safety committee meet and reviewed the information on November 26th and agreed that it did not meet the FMVSS requirements and that a recall was to be issued.
