11/14/2018 – Report was made of a spindle weld failure during transport of a new unit to a dealer. Dexter went to the unit, inspected the failure, and replaced the axles.

11/19/2018 – Report of a second spindle weld failure. Investigation opened. All Montana units were put on hold and axles were inspected.

11/26/2018 – Dexter submitted a defect notice to Keystone RV stating that a specific run of axles with the serial number of 133160828 have a potential for an improperly located spindle weld. Investigation called for to determine affected unit range.

11/28/2018 - Investigation concluded and scope completed.

# **Description of Remedy :**

Description of Remedy Program :	The remedy is to inspect the axle tag to determine if the axle is affected according the serial number. If the serial is 133160828, the axle will need to be replaced.
