Chronology:

On July 19, 2018 an internal audit was conducted and concern was brought about the way a group of LP lines were routed. It was determined these lines were not routed to design specification and did not have edge protection. This was followed by an internal rework campaign on July 19, 2018 which applied edge protection. A meeting held on August 8, 2018 determined more research was needed to identify population, and risk. After reviewing a cross section of units built on Line #2 between 2013 and 2017, it was determined that Line 2 followed the installation instructions and would not be included in the population. An internal review of LP Hose at a closeout panel was completed on November 19, 2018.
