#### Chronology :

In early June 2018, Thomas Built Buses identified an issue with the adhesive placement on a bus during production. DTNA immediately began an investigation to determine the scope and potential consequences of the issue. An inspection of buses in process noted some level of adhesive misplacement on 5 additional buses. In mid-June tensile testing was conducted on joint samples that indicated they may not meet the FMVSS 221 joint strength if the adhesive was not in the proper location. In early July 2018, an individual assembler was identified on the second shift that did not always properly place the adhesive. All buses built on second shift were placed on hold for inspection of the roof header joints. In mid-August 2018, the inspection of the buses placed on hold was completed. An additional inspection on buses built on first shift confirmed that the issue was only present on buses built on second shift. At the end of August 2018, a bus without adhesive was tested to FMVSS 220 and the Kentucky Pole test. DTNA received the test reports at the end of September 2018, which indicated the bus passed both FMVSS 220 and the Kentucky Pole test. DTNA continued working to identify potentially affected vehicles. DTNA found that it was not possible to identify the buses that were built by the operator in question. October 2018, during review of the test results, it was determined that further analysis was required. November 2018, updated test results were received for review. On December 10, 2018, out of an abundance of caution, DTNA decided to conduct a voluntary recall on certain Thomas Built Buses Saf-T-Liner C2 School buses that may have some level of adhesive misplacement.
