Description of Noncompliance:

Description of the Noncompliance: Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain C-class vehicles (205 platform) the headlamps

might have been adjusted outside production specifications.

FMVSS 1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2: NR

Description of the Safety Risk: In consequence, the low beam range might not comply with local legal

requirements.

Even in this case, blinding of oncoming traffic can be ruled out as the setting range does not exceed 0.00%. An insufficiently illuminated roadway would

increase the risk of a crash.

Description of the Cause: Due to wear of the headlight adjustment system the headlights were not

adjusted according to production specifications.

Identification of Any Warning The customer might be made aware of the issue by reduced headlight range.

Chronology:

In March 2018, DAG launched initial investigations after routine quality checks revealed improper headlamp adjustment on single vehicles.

In April 2018, root cause analyses were initiated.

In May 2018, wear of the headlamp adjustment system in the plant was identified as the root cause.

 $Subsequently, the \ headlamp\ adjustment\ system\ was\ optimized.$

From August 2018 on, further checks of production data were conducted to identify to what degree the headlamp of each vehicle might have been misadjusted. This investigation revealed that not only single vehicles were affected by this issue but the whole production range.

Finally, it was concluded that blinding of oncoming traffic can be ruled out.

However, DAG determined that local legal requirements might not be met.

Description of Remedy:

 $Description\ of\ Remedy\ Program:\ As\ a\ precautionary\ measure,\ an\ authorized\ Mercedes-Benz\ dealer\ will\ first$

check the basic setting of the headlamps on the affected vehicles and correct it, if necessary. Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since all involved vehicles remain covered under the vehicle's New Vehicle Limited

Warranty.
