Description of the Defect : Certain 2018 model Great Dane Champion CL Drop Deck trailers built in our Brazil IN manufacturing facility equipped with aluminum crossmembers were built with spare tire carriers installed with nuts and bolts instead of huck bolts as per the design.

FMVSS 1 : NR

Description of the Safety Risk : The nuts and bolts may loosen up and pull through the web of the aluminum crossmembers which may allow the spare tire carrier to become detached from the trailer. A detached tire carrier could become a road hazard that may lead to a collision or lose of control of other vehicles possibly leading to injury or death.

Description of the Cause : Incorrect attachment fasteners were used.

Dec. 13, 2018 a customer reported that a tire carrier had come loose while on the road causing damage to the understructure of the trailer.  
Dec. 14, 2018 an internal investigation determined that this tire carrier was not installed with the fasteners called out in the design drawings, and that it was likely that all 100 trailers in this order were installed using the incorrect fasteners.  
Dec. 20, 2018 Filed initial notice of defect with NHTSA

**Description of Remedy :**

Description of Remedy Program : Remove the nuts and bolts and reinstall the tire carries using huck bolts and washers.  
How Remedy Component Differs from Recalled Component : After the remedy the tire carries will be installed with the correct fasteners that will not potentially loosen up.
