



## Part Pre-Shipment – Takata Air Bag Recalls

To: All Chevrolet, Buick, GMC, and Cadillac Dealers

The National Highway Traffic Safety Administration (NHTSA) is overseeing efforts across all vehicle manufacturers to help improve completion rates for the Takata air bag recall. To support Dealership readiness to service remaining vehicles involved in Product Safety Recalls 14491, 14735, 15041, 15043, 15406, 15438, 15815, 15816, 15817, and 15826, 17009, 17476, and 17477 beginning July 23, 2018 Dealerships with remaining assigned vehicles but with no inventory on hand as of July 2, 2018 will be shipped an air bag assembly needed to complete the recall.
