GSX-R1000/R L7, L8 ECM Replacement and Drive Chain Inspection Recall Campaign SUBJECT: (GSX-R1000, R1000A, R1000R, R1000RA, R1000RZ, R1000RZA L7,L8)

Dear Sirs and Madams.

This letter is to inform you of the "ECM Replacement and Drive Chain Inspection Recall Campaign" for GSX-R1000/R L7, L8

When upshifting between first and second gear, if the rider fails to engage second gear, a neutral condition will exist and continued opening of the throttle will cause very high engine RPMs. If the rider shifts into second gear without disengaging the clutch under the very high engine RPM condition, an excessive load can be applied to the powertrain, which can cause the drive chain to stretch and, in the worst case, the drive chain can come off or break.

If the drive chain comes off or breaks, the motorcycle will lose power.

In view of the nature of this problem, Suzuki Motor Corporation (SMC) has decided to carry out the Recall Campaign in your market. The details are explained in the following pages.

You are kindly requested to organize the Recall Campaign for the affected units in your market. If you are required to report to your authority, please contact them according to your law.

If you have affected units in your warehouse, you are required to remedy them before releasing to your dealers. You are also immediately required to instruct your dealers to remedy the affected unit in stock if any, before delivering them to the customers.

Please make sure that no customers will receive the affected units without appropriate Recall Campaign remedy.

We apologize for any inconvenience this may cause to you. Your cooperation and assistance will be highly appreciated.

#### Action

- 1) For the affected units before retail sales, you are requested to remedy them before delivering them to the customers.
- 2) For the affected units after retail sales, contact the customers of the units to let them bring their vehicles to your authorized dealers after replacement parts are ready.
- 3) Order the necessary quantity of parts to SMC after replacement parts are ready.
- 4) Report to the authority according to your law.
- 5) Issue service bulletin to dealers and customer letter to owners.

Note: It is necessary for the immobilizer equipped motorcycle (Spec. E14, E21, E24 E38, and E43) to re-register at least two keys after ECM replacement. Please ask the customers to bring all keys they have.

6) Perform a corrective work following the repair instructions.
