



**IMPORTANT SAFETY RECALL**  
**NHTSA Recall No. 18V168**

Dear Supreme Distributor/Dealer:

Supreme Corporation has decided that a defect which relates to motor vehicle safety exists in certain model year truck bodies equipped with specific marker lights. Supreme is conducting a safety recall to address this condition.

**What Vehicles Are Affected?**

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Supreme Corporation has decided that a defect exists which relates to motor vehicle safety in certain model year 2013-2017 Supreme Signature Van, Iner-City, Kold King and Spartan truck bodies. A list of affected VINs is enclosed.

**What is the Issue?**

Certain Supreme truck bodies were equipped with Kidde Corporation fire extinguishers that are subject to US-CPSC recall 18-022. According to Kidde, the fire extinguishers can become clogged or require excessive force to discharge and can fail to activate during a fire emergency. In the event of a fire, if the fire extinguisher does not work correctly, there is an increased risk of injury.

**What Should You Do?**

Please determine whether any of the vehicles listed on the enclosed VIN list remain in your inventory. Any covered vehicles that remain in your inventory must be repaired prior to delivery to purchasers.
