



**IMPORTANT SAFETY RECALL**  
**NHTSA Recall No. 18V256**

Dear Supreme Distributor/Dealer:

Supreme Corporation has decided that a defect which relates to motor vehicle safety exists in certain model year truck bodies equipped with specific marker lights. Supreme is conducting a safety recall to address this condition.

**What Vehicles Are Affected?**

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Supreme Corporation has decided that a defect exists which relates to motor vehicle safety in certain model year 2013-2017 Kold King truck bodies. A list of affected VINs is enclosed.

**What is the Issue?**

Due to insufficient weld penetration it is possible the floor frame rail could become detached from the structural crossmembers. Detachment of the floor frame rail could lead to the body separating from the chassis causing injury or property damage.

**What Should You Do?**

Please determine whether any of the vehicles listed on the enclosed VIN list remain in your inventory. Any covered vehicles that remain in your inventory must be repaired prior to delivery to purchasers.
