This is to notify you of the Recall Campaign LAUNCH concerning the rear brake system of 9,045 MY 2018 166 and 292 (GLE-Class, GLS-Class, GLE-Coupe) platform vehicles. The recall campaign will be visible on the www.safercar.gov website and may generate questions from customers. Affected VINs will be flagged as "OPEN" in VMI on August 28, 2018.

Issue	certain GLE-Class, (caliper piston coati cause gas to tempo may lead to reduce	T), the manufacturer of Mercedes-Benz vehicles, has determined that on GLS-Class, and GLE-Coupe vehicles (166 and 292 platform), the rear brake ng was not applied according to manufacturer specifications which may brarily be trapped then released into the rear brake hydraulic circuit. This ed braking performance, reduced ESP performance, and/or elongated brake might increase the risk of a crash.

Once the remedy is available, the vehicles will be flagged as "OPEN" and Work Instructions will be available in Star TekInfo Once the repair is complete, the vehicle may be sold or leased. Loaner and demonstrator vehicles may continue to be driven, but must not be retailed until repaired.			
Additionally, given this notice, it is <u>a violation of Federal Law</u> for <u>car rental companies</u> to rent new MY18 GLE-Class, GLS, or GLE-Coupe vehicles covered by this notification until the vehicle has been repaired.
