

1	Check, whether the vehicle is affected by the measure.	For authorized Mercedes-Benz service partners, only the entry in the "Extended VEGA Application" (EVA) system, in the "Current" tab is decisive. An additional test of the affected vehicles in the workshop information system (WIS) or on the vehicle list is thus not necessary. If the vehicle is affected by the measure. Unly perform operation steps 4 to 7 once.

2	Unlock vehicle.	To do so, press "unlock" button (1).
3	Lock vehicle.	To do so, press "lock" button (3).
4	Operate door handle (4) of respective vehicle door.	Pull door handle (4) into its final position and hold it in this position.
5	Unlock vehicle.	To do so, press "unlock" button (1).
6	Slide door handle (4) back slowly.	Let door handle (4) of vehicle door slide back as slowly as possible. Otherwise, it is possible that the test of the door lock is not expedient.
7	Operate door handle (4).	Do not repeat operation steps 4 to 7. Otherwise, the affected vehicle door can be opened although the door lock is defective. If the vehicle door does not open on the first try. Continue with operation step 8. If the vehicle door opens on the first try. The door lock functions correctly.
8	Replace affected door lock. - Remove/install front door lock - Remove/install sliding door lock
