Re: Subaru Service Loaner Program ("SSLP") vehicles grounded due to recall notice (WTW-82).

Subaru Acceptance Corp. ("SAC") is today announcing a floor plan program for SAC floorplan financed SSLP vehicles effected by the Combination Meter Reprogramming recall notice (WTW-82).

Vehicles currently on the SAC SSLP floor plan, that must be removed from SSLP service due to this recall, will be eligible for continuation on the SAC SSLP floor plan for up to an additional 180 days after removal from the TSD WebDRIVE SSLP Portal.

To qualify for this extension, please complete the attached *SSLP Floor Plan Extension Request Form* and send the signed form and the **corresponding vehicle titles** by overnight mail to:

The SAC SSLP interest rate of Prime rate less 1.25 percent and current curtailment schedules will remain in effect. Retailers will be permitted to keep these extended units on their SAC SSLP floor plan until June 1, 2019 or until they are sold and paid off or transferred to the retailer's primary floor plan.

Retailer's not currently on the SAC SSLP floor plan are not eligible for this program but may apply for an SSLP floor plan with SAC and transfer all SSLP units, including units requiring extension, to SAC. In addition, SAC has recently revised our full line floorplan program; should you be interested in this as well, please contact us.
