What's New Abstract	Safety Recall – Parts are now available - Certain 2.1m vehicles equipped with side extender mounted intermediate marker lamp/turn signals do not meet FMVSS 108, Table 1-a requirements, for intermediate side marker lamps and reflex reflectors for vehicles 30 ft. and greater overall length. Failure to adequately warn surrounding or oncoming motorists of vehicle presence during conditions of reduced visibility may increase the risk of a crash.

Introduction	<p>Kenworth Truck Company has determined that a defect, which relates to motor vehicle safety, exists in certain T680, T880, and W990 chassis manufactured from December 10, 2012 through October 10, 2018 fail to conform to Federal Motor Vehicle Safety Standard (FMVSS/CMVSS) No. 108 - Table 1-a requirements, which require an intermediate side marker lamp and reflex reflector.</p> <p>Failure to adequately warn surrounding or oncoming motorists of vehicle presence during conditions of reduced visibility may increase the risk of a crash.</p> <p>Revision Notes 01/07/2019: Recall has been updated with repair and warranty claim information.</p>

Review the attached chassis list for your dealer code and schedule your customer(s) for service if their chassis is on the list. 2. If you are not using Service Management to start repair orders, review DWWC or SIR for “Complete” next to the “18KWF” campaign code prior to performing this repair. 3. Follow the procedures below to install reflective tape below the extender mounted marker lamp/turn signal.

Procedure	<ol style="list-style-type: none">1. If needed, print a copy of the template located in the attachments (there is a decimal and fractional version of the template, print the template that works best for you). Ensure the measurements indicated on the template are accurate, and then cut the template out of the paper.2. Clean the area below the extender mounted intermediate marker lamp/turn signal.3. Position the opening in the template over the intermediate marker lamp/turn signal.4. Install the reflective tape in the opening at the bottom of the template.5. The finished result should be similar to this image.
