Dear Mitsubishi Fuso Truck Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

The Walter Kidde Portable Equipment Company Inc. has decided that a defect which relates to motor vehicle safety exists in the Kidde fire extinguisher in certain 2004 - 2017 model year FE84D, FE85D, FEC52, FEC72, FEC92, FGB72, FK61F, FM657 or FM65F Mitsubishi Fuso trucks manufactured between April 16, 2003 and March 3, 2017. The fire extinguishers can become clogged or require excessive force to discharge and can fail to activate during a fire emergency. In addition, the nozzle can detach with enough force to pose an impact hazard.



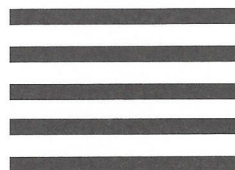
