# **IMPORTANT SAFETY RECALL**

(NHTSA Recall Number: 18V257) This notice applies to your vehicle: (Insert VIN)

Dear Kia Niro Owner:

## Kia has identified a defect in your vehicle which relates to motor vehicle safety

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Kia Motors has decided that a defect which relates to motor vehicle safety exists in certain 2017 MY Kia Niro HEV vehicles. The defect may cause an electrical short which increases the risk of a fire. A fire can increase the risk of injury. Our records indicate that you own or lease one of the potentially affected vehicles.

## What Is The Problem?

The Hydraulic Clutch Actuator (HCA) in your vehicle may have a damaged oil seal causing oil to leak and accumulate in the phase cap area of the HCA housing. As a result, an electrical short can occur which may result in thermal damage

and illumination of the HEV warning light . This increases the risk of a fire.

## Kia Will Inspect And If Necessary, Replace The HCA Assembly At No Cost For Parts Or Labor To You

Kia has advised its authorized dealers to inspect the HCA phase caps for oil leaking and contamination. If there is oil leaking and contamination, the HCA assembly will be replaced. If there is no oil leaking and no contamination, new phase caps will be installed with additional sealant for added protection. The estimated time which will be required to repair your vehicle is approximately three (3) hours, depending on the dealer's schedule. We recommend that you contact the dealer for an exact estimate of how long they may need the vehicle and schedule a service appointment to minimize inconvenience (most Kia dealers have online appointment scheduling via their dealership websites to maximize your convenience).

#### What Should You Do

- In the interest of the safety of your passengers, as well as your own safety, please immediately contact your Kia dealer to arrange for the recall repair to be conducted. If your HEV warning light is illuminated, please contact Kia Roadside Assistance at 1-800-333-4Kia (4542) to arrange for your vehicle to be towed to your nearest Kia dealer.

If you have incurred expense to remedy this issue prior to the date of this notice, you may have the opportunity to obtain reimbursement for that expense. Pursuant to the General Reimbursement Plan issued by Kia pursuant to Federal Regulation 49 CFR 573.13, Kia will use its best efforts to respond to your claim within sixty (60) days of receipt and at that time Kia may either accept or reject that claim or it may request more information to evaluate the claim.

#### Have You Changed Your Address Or Sold Your Kia?

If you have changed your home address, sold your Kia vehicle, or no longer own your vehicle, please complete the attached prepaid "Change of Address/Ownership" card and mail it to us. You can also contact the Consumer Assistance Center phone number listed above.

## What If You Are A Vehicle Lessor?

Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

#### QR Code Use:

- A QR Code is a square, 2-dimensional barcode that can be read by mobile devices loaded with an appropriate barcode or **QR Code Reader App**. The app reads the barcode image and then launches/uploads the specific information the code contains, such as URLs, text, photos, videos.
- With a mobile device, **download a QR Code Reader App**. With many devices, you can do this through an app store or marketplace.
- Open the QR Code Reader App on your mobile device. The app will utilize your device's camera. Center the code in the camera viewing area. With some apps, the URL or other information will automatically load when the code is recognized. For others, you may have to snap or take a picture of the QR code.
