Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

- · A remedy is available for your vehicle.
- Schedule an appointment with your authorized Mercedes-Benz dealer as soon as possible.
- This repair will be provided free of charge.

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has decided that certain Model Year ("MY") 2018 GLA-Class vehicles fail to conform to Federal Motor Vehicle Safety Standard ("FMVSS") number 225 (Child Restraint Anchorage Systems). Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

DAG has determined that on certain MY18 GLA-Class "Ice Edition" vehicles (156 platform) the central child seat tether anchorage point of the rear seat may be missing and the vehicle therefore would not comply with FMVSS number 225, leading to the inability to secure a child seat tether to this point per the Operator's Manual. This may increase the risk of injury.

What will your DEALER DO?

An authorized Mercedes-Benz dealer will replace the rear center seatback for the affected vehicles. This service will be provided free of charge. We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be up to **approximately 2 hours**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.
