Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2018 GLE-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN? DAG has determined that on certain MY 2018 GLE-Class vehicles (W166 platform) the bonding primer of the front cover and/or rear fixed glass element of the panoramic sunroof might not meet current production specifications. An incorrect bonding primer may not have the required adhesion durability to allow for proper adhesion of the front cover or rear fixed glass elements of the panoramic sunroof. As a result, the front cover and/or rear fixed glass of the panoramic sunroof could detach from the vehicle and become a road hazard, increasing the risk of a crash. What will your DEALER DO? An authorized Mercedes-Benz dealer will check the panoramic sunroof, and replace it, if necessary. This service will be provided free of charge. We are dedicated to always delivering the best customer experience and respect for your time is a top priority. While the minimum repair time can be up to 10 hours, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time. In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.
