Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2018 E-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

DAG has decided that on certain MY 2018 E-Class cabriolet vehicles (238 platform), the ISOFIX cross-member for child seats, might not have been mounted according to current production specification. While the child seats can still be secured to the ISOFIX anchoring points, in case of a crash, the ISOFIX cross-member might partially detach from the car body. This could increase the risk of injury for a child in a child seat.

What will your DEALER DO?

An authorized Mercedes-Benz dealer will check the ISOFIX cross-member and replace it, if necessary. This service will be provided free of charge. We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be up to 2 hours, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.
