Recreational Vehicle Safety Recall Notice

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2017, 2018 and 2019 Durango, Venom and Sidewinder models. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with the required certification label listing the wrong tire size. The current label states the tires are ST235/80R16G. The correct tires are ST235/85R16G. When new tires are needed, the consumer could install the wrong size tires that have a lower load capacity which could result in increased tire failures and personal injury.

What we will do

The remedy is to replace the incorrect label with a new label that has the correct tire size information listed as ST235/85R16G. The repair should take approximately 15 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.  If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
