Dear Volvo Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volvo Car USA LLC (Volvo) on behalf of Volvo Car Group, has decided that a defect which relates to motor vehicle safety exists in certain model year 2019 XC60 T8 vehicles.

#### The reason for Recall R39901:

Volvo has identified that the charge cord may have been manufactured with an incorrect capacitor that could pose a risk of a fire and/or present a shock hazard, increasing the risk of injury or death.

Your authorized Volvo retailer will inspect the charge cord serial number and replace it if necessary. Please bring the charge cord with you when visiting your Volvo retailer for this recall.

## DO NOT USE THE CHARGE CORD UNTIL THIS RECALL HAS BEEN COMPLETED

## What you need to do:

Please contact your authorized Volvo retailer for an appointment. The repair procedure will be <u>performed at no cost</u> and can take up to 30 minutes to complete. However, the time your Volvo retailer requires to service your vehicle may be slightly longer depending on the vehicle.

If you had previously paid for this repair to be performed, prior to receiving this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
