This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that your vehicle, with the VIN shown above, fails to conform to Federal Motor Vehicle Safety Standard (FMVSS) 206: Door Locks and Door Retention Components.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

| <b>What is the issue?</b>                 | On your vehicle, it is possible that the incorrect door striker bolt was installed, which may result in reduced door striker strength.   |
| <b>What is the risk?</b>                  | This may allow a door to open in the event of a crash, increasing the risk of injury.  |
| <b>What will Ford and your dealer do?</b> | Ford Motor Company has authorized your dealer to replace the door striker bolts on all four doors, free of charge (parts and labor).   |
| <b>How long will it take?</b>             | The time needed for this repair is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.   |
| <b>What should you do?</b>                | Please call your dealer without delay and request a service date for Recall 18C06. Provide the dealer with your VIN, which is printed near your name at the beginning of this letter.<br>If you do not already have a servicing dealer, you can access <a href="http://www.Fordowner.com">www.Fordowner.com</a> for dealer addresses, maps, and driving instructions.<br>Ford Motor Company wants you to have this safety recall completed on your vehicle. The vehicle owner is responsible for making arrangements to have the work completed. |

**Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.**
