Update to Load Carrying Capacity Modification (Addendum) Label (18V-753) IMPORTANT SAFETY RECALL

Dear Owner:

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Southeast Toyota Distributors, LLC has decided that your vehicle falls to conform to Federal Motor Vehicle Safety Standards (FMVSS) No. 110, "Tire selection and rims" as it relates to Load Carrying Capacity Modification (Addendum) Labels.

What is the condition?

The Addendum Label is a yellow label (see diagram below) located on the driver's side center pillar. The label provides the net weight of accessories added to your vehicle which were not already taken into account in the vehicle occupant and cargo carrying capacity located on the Tire and Loading Information Label.

In the affected vehicles, the current Addendum Label is not correct in that it is not accurate to within one percent (1%) of the weight of accessories installed on the vehicle. This could result in a driver overloading the vehicle which may increase the risk of a crash.





What will Southeast Toyota Distributors, LLC do?

Southeast Toyota Distributors, LLC will replace the load carrying capacity modification (addendum) label at NO CHARGE. In addition, Southeast Toyota Distributors, LLC will arrange for the removal of an SET accessory at NO CHARGE, and a full refund of the purchase price of the SET accessory. The amount of time required for this will be approximately one hour or less. However, depending upon the dealer's work schedule, it may be necessary to make the vehicle available for a longer period of time.

What should you do?

Please call Southeast Toyota Distributors, LLC at 1-800-301-6859, identify your vehicles as a vehicle in which an SET accessory must be removed, and provide the VIN. Southeast Toyota Distributors, LLC will discuss your options and make arrangements with your local Toyota dealership.

- · If you are a vehicle Lessor, Federal law requires you to forward a copy of this notice to the Lessee within ten days.
