Safety Recall 18KWF – T680, T880, and W990 Side Extender Intermediate Marker Lamp Reflector

This notice applies to your vehicle; VIN:



Dear Kenworth Customer,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Kenworth Truck Company has decided that certain T680, T880, and W990 chassis manufactured from December 10, 2012 through October 10, 2018 fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 108. The intermediate side marker lamp/turn signals, mounted to the side extenders, do not include reflex reflectors as specified by FMVSS 108. The absence of reflex reflectors could decrease vehicle conspicuity and potentially increase the risk of a crash causing injury and/or damage to property.

The problem is... Certain vehicles are equipped with side extender mounted intermediate marker

lamp/turn signals that do not include a reflex reflector as required by law.

What your dealer will do... Dealers will install reflective tape below the extender mounted marker

lamp/turn signal.

What you must do ... Contact your Kenworth Dealer to schedule an appointment for repair

Kenworth has initiated a recall to remedy the defect. This repair should take approximately **1.0 Hour** and will be performed at no charge to you. Please contact your Kenworth dealer immediately to schedule an appointment for this repair. To find your nearest Kenworth dealer, please visit Dealer Locator at www.Kenworth.com.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
