Dear Mr. Cousin,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect which relates to motor vehicle safety exists in certain vehicles of the models and model years listed above. Our records show that you are the owner of a vehicle affected by this action.

What is the issue?

A brake line installed on the front axle may corrode over time. As a result, rust particles could be deposited in the filter elements inside the hydraulic unit and could block it, potentially impairing the performance of the front brakes. Reduced braking ability could increase the risk of a crash.

What will we do?

Porsche is conducting a safety recall and replacing the affected components. Vehicles affected by this action will be recalled to the workshop to have the brake line and other possibly damaged braking components replaced. These repairs will be completed at no charge to you.

What should you do?

Please make contact with your authorized Porsche dealership to schedule a repair appointment, and to arrange in advance for a Porsche loaner vehicle should you require alternate transportation during the repair period. Replacing the affected components is expected to take approximately six to seven hours to complete.

Lease vehicles and address changes

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten days of receipt. If you have changed your address or sold the vehicle, please fill out the enclosed prepaid Owner Reply Card and mail it to us so we can update our records.

Reimbursement

This recall will be carried out at no expense to the customer. If you previously paid to have this repair performed, you may be eligible for reimbursement. For more information, please contact the Porsche Customer Commitment Department as instructed below.
