This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect which relates to motor vehicle safety exists in certain vehicles of the models and model years listed above. Our records show that you are the owner of a vehicle affected by this action.

What is the issue?

Affected vehicles were supplied with optional ski bags in which the fastening strap was sewn with an unapproved sewing thread. The affected parts do not provide the required strength based on Porsche internal safety standards. As a result, there is the possibility that the strap seams could tear under a high load and the ski bag may not be held in position during a crash. This could increase the risk of injury.

What will we do?

Porsche is conducting a safety recall and replacing the affected components. Vehicles affected by this action will be recalled to the workshop to have the ski bag replaced. These repairs will be completed at no charge to you.

What should you do?

Please make contact with your authorized Porsche dealership to schedule a repair appointment, and to arrange in advance for a Porsche loaner vehicle should you require alternate transportation during the repair period. Replacing the affected components is expected to take approximately one-half hour to complete.

Lease vehicles and address change

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten days of receipt. If you have changed your address or sold the vehicle, please fill out the enclosed prepaid Owner Reply Card and mail it to us so we can update our records.

Reimbursement

This recall will be carried out at no expense to the customer.
