Description

This Safety Campaign is being issued on certain ISV5.0 engines installed in Tiffin RV applications equipped with Accessory Drive Option CP80007. The accessory drive may experience belt slippage, resulting in decreased air compressor output and may impact vehicle air brake performance.

The action authorizes certified repair locations to replace the existing refrigerant compressor with a new low mount refrigerant compressor configuration.

Note: This field action provides retroactive coverage for repairs made in anticipation of and prior to the release of this publication.

Action

In order to qualify for repair under this field action, an engine:

- 1. will be covered Regardless of coverage status, and
- 2. must show as OPEN on QuickServe® Online for this field action.

Note: The ESN list is attached for reference.

After verifying that the engine meets the above requirements, perform the following actions:

Note: Please refer to TSB180058, Belt Noise and Front Engine Accessory Drive Belt Re-routing: Tiffin Recreational Vehicles, for detailed repair instructions.

- 1. Move refrigerant compressor from high mount to low mount position.
- 2. Change belt options to CP80008 and WP80038 for increased belt wrap on plane two belt around the air compressor.
- 3. Install AC hose service kit and re-route compressor harness.
- 4. File one claim for all parts, labor, travel and other expenses required to complete the repair.
