# **DESCRIPTION:**

This Safety Campaign is being issued on certain ISV5.0 engines installed in Blue Bird School Bus applications equipped with Accessory Drive Option CP80009. The accessory drive may experience belt slippage, resulting in decreased air compressor output and may impact vehicle air brake peformance. The action authorizes certified repair locations to replace the existing air compressor belt with a new shorter belt.

**NOTE:** This repair will disable the rear air conditioner compressor. Cummins is currently developing a longer term solution that will enable the rear air conditioner compressor. The Campaign will be revised and updated at this time.

**NOTE:** This field action provides retroactive coverage for repairs made in anticipation of and prior to the release of this publication.

# ACTION:

In order to qualify for repair under this field action, an engine:

- 1 will be covered Regardless of coverage status, and
- 2 must show as OPEN on QuickServe® Online for this field action.

**NOTE:** The ESN list is attached for reference.

After verifying that the engine meets the above requirements, perform the following actions:

- 1 Refer to Section 12 of ISV5.0 CM3230 V104 Service Manual 4367291.
- 2 Remove existing air compressor drive belt PN 4378309
- 3 Install new shorter air compressor drive belt PN 4391015, eliminating belt wrap around upper mount air conditioning compressor pulley, disabling rear AC.
- 4 File one claim for all parts, labor, travel and other expenses required to complete the repair.

Materials removed as a result of this field action **must** be scrapped.
