RENOTIFICATION

Dear «Owner_name»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2018 & 2019 Model Year KZRV Sportsmen Travel Trailers. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with an outside kitchen option. Proper sealing tape was not installed on the propane gas line for the outside kitchen. In addition, the testing to insure the propane line does not have a leak was not performed. A leak of propane gas could result in a fire or explosion resulting in personal injury or death. The propane leak detector in your travel trailer should alert you to a leak and the trailer exited immediately.

What we will do

The remedy is to inspect the propane system for leaks and correct if necessary. This defect will be corrected at no expense to you, the owner. The repair should take approximately 30 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle. If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
