**RENOTIFICATION**

Dear «Owner\_name»:

This notice is sent to you in accordance with the requirements of the Canadian Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2018 & 2019 Model Year KZRV Sportsmen 333BHK Travel Trailers. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

***Reason for this recall***

The vehicles subject to this recall were built with the liquid propane (LP) supply lines routed through a wheel well and are not adequately protected from debris. The LP system may become damaged by debris and could result in a fire or explosion resulting in personal injury or death.

***What we will do***

The remedy is to install a steel plate which will protect the LP system from debris. The repair should take approximately 60 minutes to complete.

***What we need you to do***

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle. If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
