This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2017-2019 Sonic 190VRB. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with an liquid propane (LP) manifold placed too closely to the axle. As a result, the axle may contact the manifold causing damage which will result in a leak that could result in a fire or explosion resulting in property damage, personal injury or death.

What we will do

The remedy is to relocate the LP manifold away from the axle. The repair should take approximately 1 hour to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
