# <u>Passenger Frontal Air Bag Inflator May Explode</u> – Safety Recall 1317F NHTSA 18V-717

Dear Mazda Owner:	
This notice applies to your vehicle: 20xx Mazda Modelname VIN	

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mazda Motor Corporation has decided that a defect which relates to motor vehicle safety exists in 2010-2013 Mazda6, 2010-2015 CX-9 and 2010-2012 CX-7 vehicles. A recall notification was sent in July 2019 to you or the prior registered owner. Your vehicle is still unrepaired and included in this Safety Recall. Please read this letter and make an appointment when possible at your local dealer who may also have alternative repair options available. # What is the problem?

In the subject vehicles, continued exposure to high levels of absolute humidity may cause the passenger frontal air bag inflator housing to rupture and deploy abnormally in the event of a crash necessitating deployment of the passenger frontal air bag. An inflator rupture could result in metal fragments striking the driver or other vehicle occupants, resulting in serious injury or death. It is extremely important to schedule this repair as soon as possible, to ensure your safety and the safety of your passengers.

#### What will Mazda do?

Your Mazda dealer will replace the passenger frontal air bag inflator with a modified one, free of charge. The repair should take less than one hour to complete; however, it may take longer.

Mazda will provide alternate transportation when your vehicle is at an authorized Mazda dealership for a recall repair. To be eligible for alternate transportation, you must schedule an appointment with any authorized Mazda dealer so that they can discuss and accommodate your needs.

### What should you do?

#### Protect What is Important to You.

Please make an appointment with any authorized Mazda dealer to have the airbag inflator replaced as soon as possible. You can make a dealer appointment online at <a href="www.MazdaRecallInfo.com">www.MazdaRecallInfo.com</a>. Until this repair is performed, do not allow passengers to ride in the front passenger seat. Making an appointment provides the dealer the opportunity to reserve the necessary part for your repair and plan their service activity, thus minimizing your wait time and inconvenience this recall may cause you. You do not need to bring this notice to the dealer, but it may assist in the check-in process.

## Moved or no longer own this vehicle?

Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
