By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Pre-Owned Vehicles in Dealer Inventory: Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

The removal process is recreated here. The service manual for Karma Revero can be referenced as a guide. This section is found beginning on page 473 of the Service Manual PDF, Restraint Systems Section. The service manual instructions guide the technician to access the side curtain airbags by lowering the headliner. This will include removal of associated trim and release of wiring connectors for access.

Have a camera available and ready. Capture images of the <u>removed airbag assemblies and the new</u> airbag assemblies prior to installation. These images showing both serial numbers (clearly and readable) must be attached to the recall warranty claim, the TSS case and retained with repair order documentation as well. This is needed for the NHTSA recall records.

This procedure will involve replacing both the installed Curtain Side Airbag Assemblies with Curtain Side Airbag Assembly - LH P/N C131148801105 and Curtain Side Airbag Assembly - RH P/N C131148801205. These will be replaced with the new parts made available to the service center in the supplied kits:

Kit-Airbag Service LH, P/N C161148600300 (including 8 new bolts with adhesive) and Kit- Airbag Service RH, P/N C161148600400 (including 8 new bolts with adhesive).

Over View:

- 1) Cover the dash and seats with plastic sheeting, to avoid or minimize any soiling or dye transfer from surfaces to the headliner
- 2) Remove the rear seat backs and cushions
- 3) Remove the package tray, and the c-pillar trim
- 4) Remove the upper b-pillar trim
- 5) Remove the a-pillar trim
- 6) Remove the front and rear dome light assemblies (disconnecting any harnesses as needed) and the ADAS cover
- 7) Lower the front seat to a lay back position for the most access
- 8) Perform the 12 Volt disconnect
- 9) Remove the coat hooks, and be prepared to lower the headliner
- 10) Lower the headliner and slide it forward
- 11) Begin at the rear inflator and unplug the inflator and remove the fastener
- 12) Remove every fastener holding the side curtain air bag
- 13) Reassemble, using the new Curtain Side Airbag assemblies, in reverse of disassembly
- 14) Torque for reinstall is 6 +/- 1.0 Nm for the bolts fastening the side curtain air bag. Be sure to use the new specified bolts as indicated. Do not re-use the bolts from the assembly





Note the central clips, and use a panel tool to aid in removal

Remove both curtain side air bags. Deform the inflator mounting bracket (bend it with pliers as in fig. 16a) so that this part cannot be reused or mistakenly reinstalled (indicated in fig. 15c) Again take pictures of the airbag serial numbers (found below the Karma Part number) and record

these from the removed air bags (fig. 16b).

It is recommended to use a white paint pen and write the last six (6) digits of the VIN on the metal surface of the side curtain airbag inflator to indicate a no-use condition part and to identify this as removed to be returned to Karma Automotive.

Prior to installation of the new Curtain Side Airbag Assemblies, these must be prepared properly (see following pages). It is critical for reassembly to perform these steps!

Remove captured bolts (one by one to ensure correct bolt position) from new Curtain Side Airbag C131148801105 (LH), C131148801205 (RH). Use retrofit bolts C141800803200 (Bolt-Hex SEMS Flat M6 X 1.0 X 19.5 PC10.9 with Adhesive included in each airbag service kit (fig.17a)

Resuse the Takata bolt retainer washer, in all locations indicated to install new Curtain Side Airbag.

Place new airbag assemblies on a flat clean surface. (fig.17b, 17c note the three clamps on the inflator) and the anti twist stripe, on the cover, this should remain straight on install.

Remove eight (8) lock-washers from the LH/RH Airbag assembly fasteners. Note: Only remove fasteners #1-#8 as shown in (fig.17d)





The new bolt is 6mm fastener C141800803200 - Bolt-Hex SEMS Flat M6 X 1.0 X 19.5 PC10.9 with Adhesive (fig.18b) included in each airbag service kit.

Install the 6mm fastener as shown(fig.19a, 19b) and re-use the Takata retainer-washer, into locations #1 - #8 (as shown above in fig.17). If new washers are needed order C144900507200




Hand start 3-4 threads to assure that the bolt follows the formed threads in the hole. Tighten to torgue 6 Nm. Proceed with re-installation the reverse of removal, install torgue shown in fig.20 Do not twist the Curtain Side Airbag on installation.



Install the new parts. Proceed to reassemble the interior in the reverse order as removed. Again avoid soiling or damaging any of the interior parts:

Curtain Side Airbag Assembly - LH Curtain Side Airbag Assembly - RH C131148801105 C131148801205.

Again note, the new bag has 3 clamps, and a 15mm stripe, which should remain straight during installation, do not twist.



Reconnect the 12V system, reinstall the #10 fuse into the fuse block.

Calibrate parking brake. Initialize windows.

Check for any new bulletins while the vehicle is in the shop, perform as needed.

Verify there are no codes present with Karma Sync, test drive the vehicle.

Please return the airbags assemblies to the manufacturer. Resuse the packing material the parts were recieved in for return. Contact Karma Automotive for a return shipping label, and arrangements will be made to ship back to the distribution center.

Take care and use the appropriate torgue wrench to torgue the fasteners as indicated. In the event any fasteners fail to achieve the recommended torque (when a bolt or mounting location "strips") refer to SC-18-18-01 which is a published communication for general repair information.
