## Information about Safety Recall 01C6 - Vehicle Noncompliance

THIS RECALL REMEDY IS NOT YET AVAILABLE. We will send another letter as soon as the recall remedy is available for your vehicle.

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Volkswagen has decided that a defect, which relates to motor vehicle safety, exists in certain 2012-2016 model year Volkswagen vehicles. Our records show you are the owner of a vehicle affected by this recall. At this time, the recall remedy is not yet available.

**Recall Description:** A small number of zero-series vehicles (very early production vehicles) were sold as used after they were no longer needed for internal use.
