IMPORTANT SAFETY RECALL

Valve Stem Keeper

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain [2019 Jeep® Cherokee] vehicles.

WHY DOES MY VEHICLE NEED REPAIRS?

The engine in your vehicle ^[1] may have been built with a missing valve stem keeper or a reversed installed camshaft cap. A missing valve stem keeper may allow the valve to drop into the engine cylinder, leading to engine damage. An engine built with a reversed installed camshaft cap may allow material transfer to the camshaft bearing and subsequent camshaft seizure. **A missing valve stem keeper or a reversed installed camshaft cap may result in loss of motive power. A sudden loss of motive power can cause a vehicle crash without prior warning.**

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

The remedy for this condition is not currently available. We are making every effort to finalize the remedy and obtain parts as quickly as possible, and will service your vehicle free of charge (parts and labor).

FCA US will contact you again, by mail, with a follow-up recall notice when the remedy and/or parts are available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment ^[2]. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit www.fcarecallreimbursement.com to submit your reimbursement request online ^[3]. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
