Affected vehicles were issued non-compliant replacement certification labels. Similar vehicles not included in the recall were originally applied with compliant certification labels.

573.6(c)(5)

Defect description:

The software programming for the certification label printer had incorrect settings for printing replacement certification labels, which resulted in replacement certification labels printed with random characters instead of the vehicle's manufacturing date. Failure to display the vehicle's manufacturing date on the certification label does not comply with 49 CFR Part 567.4, Requirements for manufacturers of motor vehicles.

573.6(c)(6) **Chronology:**

March 26, 2018

While performing body repairs on a recently assembled vehicle, a factory associate noticed that the manufacturing date on the replacement certification label did not match the date on the original certification label.

Late March to early June 2018

Honda launched an investigation into the manufacturing date discrepancy between the original and replacement certification label. The range of potentially affected vehicles was also investigated through manufacturing records.

June 7, 2018

Honda completed the investigation and determined that non-compliance with certification label requirements exists and decided to conduct a non-compliance recall.

As of June 7, 2018 Honda has not received any warranty claims, field reports, or reports of injuries or crashes related to this non-compliance.

Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to a Honda automobile dealer. The dealer will replace the certification label for free.
