CONDITION OF CONCERN

On certain subject Mazda6 vehicles in salt belt states, it is possible the front cross member may be corroded due to suspected insufficient paint coating. Continued use of the vehicle may allow the corrosion to progress, causing the support of the right lower control arm to decrease. Passing over a pothole may result in breakage of the cross member and reduced steering control, increasing the risk of a crash.


PRELIMINARY ACTION (Until repair parts are available): Parts expected to be available in early January 2019

As repair parts are not currently available, a final repair cannot be performed at this time, and preliminary action is necessary until the parts are available.

- 1) Inspect the condition of the front cross member, and determine if it passes the inspection criteria.
- 2) a) If the cross member passes inspection, please ask the customer to return to the dealer for repair when repair parts are available (parts available notification).
 - b) If the cross member fails inspection, please arrange a free rental or loaner vehicle for the customer to use as a replacement for their vehicle until repair parts are available.

OUITLINE OF REPAIR (After Parts are Available)

- OK vehicle: If the cross member passes inspection, install a support brace and A/C drain hose, and apply anti-rust cavity wax to the cross member.
- Not OK vehicle: If the cross member fails inspection, replace the cross member with a modified one and install a drain hose.
