Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2016-2019 Keystone Fuzion and Impact Fifth Wheels and Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Reason for This Recall

It has been decided that the vehicles in the recall population have brake wiring that may touch the tires or wheels while the vehicle is in motion. Under certain conditions during travel, if the brake wires rub against the wheel or tire, there is an increased risk of property damage and poor vehicle handling.
