Dear Tabatha

Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2019 Dutchmen Aerolite, Atlas, 2019 Keystone Bullet, Cougar, Hideout, Laredo, Passport, Springdale, and 2019 Crossroads Sunset Fifth Wheels and Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Reason for This Recall

It has been decided that the vehicles in the recall population may not have a bearing cup installed in the bearing assembly. Under certain conditions during travel, if the bearing cup is not installed it could lead to a bearing failure, leading to an increased risk of property damage and poor vehicle handling.
