This letter serves to acknowledge Ivolution Sports Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Ivolution Sports, Inc. (Ivolution) is recalling certain IV2 HY808 helmets, part number Hy808, in sizes S, M, L and XL. These helmets may not adequately protect the wearer in the event of a head impact during a motorcycle crash. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 218, "Motorcycle Helmets."

Consequence:

A helmet that does not adequately protect the wearer from an impact can increase the risk of injury in the event of a crash.

Remedy:

Ivolution will notify owners and provide a full refund for the helmets. The recall is expected to begin in April 2019. Owners may contact Ivolutution's customer service at 1-951-852-6327. Ivolution's number for this recall is HY808-XL.

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Your Defect Information report states that owners will be notified between March and December 2019. Please be reminded that it is required that owners be notified of a safety defect in their helmets within 60 days of a manufacturer's notification to NHTSA of a safety defect in those helmets.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
