Subject: Air Bag Inflators May Rupture or Underinflate Bag

This letter serves to acknowledge Takata (TK Global LLC)'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Please review the following information to ensure that it conforms to your records as this information is being made available to the public. Potential Number of Units Affected: 1,400,000

Problem Description:

Takata (TK Global LLC) is recalling certain Non-Azide Driver air bag Inflators (NADI). These inflators were used in some brands of 1995-2000 vehicles and do not contain phase stabilized ammonium nitrate (PSAN) propellant. Due to a manufacturing issue, the NADI inflators may absorb moisture, causing the inflators to rupture or the air bag cushion to underinflate.

Consequence:

In the event of a crash necessitating air bag deployment, an inflator rupture may result in metal fragments striking the driver or other occupants. An underinflated air bag may not properly protect the occupant. These scenarios increase the risk of serious injury or death.

Remedy:

Takata will be working with vehicle manufacturers to determine into which vehicles the affected inflators were installed either as original or replacement equipment during service. As this work progresses, numerous vehicle recalls will likely be announced by the impacted vehicle manufacturers. The recall is expected to begin on January 24, 2020.


Please be reminded of the following requirements:
