SUSPENSION: REAR: AXLE: NON-POWERED AXLE ASSEMBLY

**Potential Number of Units Affected:** 44

## **Problem Description:**

Forest River, Inc. (Forest River) is recalling certain 2020 Shasta Oasis SST30QB and SST310K trailers. The trailers may have been built with an incorrect length axle hanger, allowing the axle to contact the chassis while moving.

## **Consequence:**

If the axle hanger contacts the chassis, it can cause loss of vehicle control, increasing the risk of a crash.

### Remedy

Forest River will notify owners, and dealers will replace the equalizers, free of charge. The recall is expected to begin November 25, 2019. Owners may contact Forest River customer service at 1-574-528-8717. Forest River's number for this recall is 53-1100.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
