 1.a) Potentially affected Cush part number population was determined by identifying all part numbers that used affected AXN axle in the Bill of Material, then finding all invoices for the potentially affected Cush part numbers in the date range provided by AXN.
 2.) The recalled products were used in an exclusive list of Cush part numbers - affecting only one customer. The specifications for these part numbers are exclusive - meaning all Cush part numbers the customer bought in AXN's specified time window would be potentially affected. Refer to Safety Recall Report 18E-088 for info on AXN's description exclusive to the recalled parts.
 3.) AXN identified 160 potentially affected units. Cush does not exclusively track AXN's serial numbers, so Cush was only able to limit the potentially affected population to 195 units, spread across 3 unique part numbers within the affected date range.
