Descriptive Information : Meritor received (2) reports from the field regarding wheel-separation incidents that occurred at low mileage, both on MX14-120 EVO axles. The affected assemblies were built between 12/13/2018 and 5/13/2019 at the Laurinburg, NC manufacturing site.

Production Dates : DEC 13, 2018 - MAY 13, 2019

Description of Defect :

Description of the Defect : Meritor MX 120 EVO axles were inadvertently missed during production. Assembling the axle without oil in the wheel end can result in over-heating of the wheel end bearings which can lead to damage and/or seizing of bearings, plastic deformation of components, and eventually wheel end separation from the axle.

Description of the Safety Risk : Loss of vehicle control or property damage could result due to insufficient lubrication of the bearings in the wheel end system.

Description of the Cause : Wheel end oil fill was inadvertently missed during production.

Identification of Any Warning that can Occur : Wheel end over-heating can be an indication of problems with lubrication or with internal component damage. As bearing damage progresses, the driver may detect an issue during vehicle operation by hearing unusual noise or by feeling unusual vibration and/or pull on the steering wheel while driving.

Description of Remedy :

Description of Remedy Program : Meritor MX 120EVO axles were inadvertently assembled without oil in the wheel end system. Customers will be reimbursed for wheel end inspection. Inspect per Meritor Maintenance Manual MM0170, page 58. If no oil is found in wheel end during inspection, Meritor will replace wheel end components from spindle out.

How Remedy Component Differs from Recalled Component : The remedied Meritor MX 120EVO axles' wheel end systems will have sufficient lubricant in the wheel end system.

Identify How/When Recall Condition was Corrected in Production : Containment established on May 14, 2019 through the introduction of an additional visual inspection and implementation of photographically capturing the presence of lubrication in the wheel end system.
