#### **Chronology:**

In early 2018, TRW (now ZF) became aware of an ESR above specification in capacitors supplied by KEMET, purportedly due to the manufacturing process at KEMET, linked to an inadvertent deployment in a vehicle in the field. ZF communicated and worked with customers and the sub-supplier to investigate root cause and analyze potentially related field returns. After further investigation, ZF identified other customers that may have received airbag control units containing potentially affected parts and informed those customers of the potential issue. On June 6, 2019, Ferrari filed a voluntary recall report with NHTSA. On June 14, 2019, Maserati filed a voluntary recall report with NHTSA. On July 17, 2019, Volkswagen and Porsche filed voluntary recall reports with NHTSA. ZF submits this report following communications with NHTSA, after becoming aware of and based on the recall filings of Ferrari, Maserati, Porsche, and Volkswagen. The root cause analysis is ongoing, and ZF is not aware of any injuries associated with this issue.
