It has been determined that 130 of the tires produced from June 18, 2018 to June 25, 2018 (Date of manufacture: 2518) have been marked without the complete tire identification number (TIN) which requires the "Date of Manufacture". The date of manufacture is the last four digits in the tire identification number indicating the week and year of manufacture.

Description of Noncompliance :

Description of the Noncompliance : The noncompliance is related to tire identification number (TIN) that needs to be molded onto the tire sidewall. It has been determined that 130 of the tires produced from June 18, 2018 to June 25, 2018 (Date of manufacture: 2518) have been marked with the complete tire identification number (TIN) which requires the "Date of Manufacture".

Description of the Safety Risk : Tires with an incomplete TIN and subject to a safety recall would be impossible to identify as being affected by a safety recall. Tires being affected by a safety recall can increase the risk of crash.

Through routine examination of distributor stock on or about January 22, 2019 it was discovered that the subject tires were missing the date of manufacture. Upon notification of the situation analysis to define the scope started and on January 25, 2019 the decision was made that in fact this was a noncompliance and required a recall.

Description of Remedy Program : Tires to be identified and scrapped
How Remedy Component Differs from Recalled Component : The remedy and the recall are the same, tires to be scrapped. Reimbursement will be conducted through regular warranty mechanism.
