Description of Remedy Program :	[All owners of the subject vehicles will be notified by first class mail with instructions to bring their vehicles to a Kia dealer. Dealers will be instructed to replace the Oil Pressure Switch (OPS) with an improved one that will detect the early onset of oil leaking. In addition, dealers will inspect the oil pan for any oil leaks. If no oil leaks are found, the vehicle will be returned to the owner. If an oil leak is found, the oil pan will be replaced. Kia will reimburse owners for repair expenses already incurred pursuant to Kia's General Reimbursement Plan filed April 10, 2018.]
How Remedy Component Differs from Recalled Component :	[A properly sealed oil pan.]
