2-2019 was reported that during routine review of unit weights and specification for 2019 model year, an error was made in two models of Mesa Ridge TT - MU and UH - the GVWR was calculated and noted higher than the rating of the Safety Chains -Engineering immediatly corrected all data used for noting the GVWR - Scope created - all MU and UH models produced for 2019 model year - 2-28-19 Safety Committee reviewed all details of incident and agreed that recall was required.
