Description of the Noncompliance : Distance traveled is accumulated in kilometers by the odometer but the label on the dial face says miles. FMVSS 101 Table 2 requires if distance is accumulated in kilometers the display needs to be labeled in kilometers.

FMVSS 1 : 101 - Control and displays

FMVSS 2 : NR

Description of the Safety Risk : The display of the vehicle's accumulated distance in kilometers while the gauge is labeled miles, could lead to driver confusion, and inspections and maintenance may occur sooner than needed, as well as possible incorrect assumptions about driver speed.

In November 2018, DTNA received a customer complaint regarding an odometer alleged to be displaying distance in Kilometers, while it was labeled miles. November, 2018 through January 2019, DTNA investigated the issue to identify scope, root cause and population. DTNA also reached out to external counsel as part of the investigation. February 2019, DTNA received clarification from outside counsel that the issue may be non-compliant with FMVSS 101. February 28, 2019, DTNA decided to voluntarily recall the affected vehicles.
